PREFACE

The Pay Research Unit (PRU) of the Department of Expenditure, Ministry of Finance brings out an "**Annual Report on Pay and Allowances of Central Government Regular Civilian Employees**" for each financial year. As in the past, the **Annual Report for 2021-22** provides statistical information on expenditure incurred by different Ministries/Departments of the Central Government on Pay and Allowances including Dearness Allowance, House Rent Allowance, Transport Allowance, Overtime Allowance, etc. in respect of its regular employees. The Annual Report also contains information on the group-wise number of sanctioned posts and of employees in position in various Ministries/ Departments.

2. The data in the Annual Report has been compiled on the basis of quarterly returns on expenditure on pay and allowances and annual returns on the strength of Central Government Civilian Employees furnished by the Central Government establishments to the PRU.
3. The Annual Report may be of use for personnel planning and for preparation of reliable estimates of financial implications of various proposals concerning pay and allowances of Central Government employees. While all efforts have been made to present the data in a meaningful manner, suggestions for further improvement would be welcome.
4. Ministry of Finance would like to thank all the Central Government Ministries/ Departments/ Organizations for their cooperation in furnishing data, without which this compilation would not have been possible. This Ministry would also like to acknowledge the contribution to the National Informatics Centre (North Block) , New Delhi.



CHAPTER - I

Salient Features



SALIENT FEATURES

1. The total expenditure on Pay and Allowances (excluding Productivity Linked Bonus/ Ad-hoc Bonus, Honorarium, Encashment of Earned Leave and Travelling Allowance) for Regular Central Government Civilian employees including employees of the Union Territories and Missions abroad is ₹ 256112.31 crore in 2021-22 as compared to ₹ 237055.09 crore in 2020-21. Thus, there is an increase in expenditure by ₹ 19057.22 crore over previous year which in relative terms works out to around 8.04%.
2. The total expenditure on pay and allowances as a percentage of Revenue Expenditure of the Central Government during the financial year 2021-22 is 7.44% as compared to 7.29% during the financial year 2020-21.
3. Almost 82.58% of the total expenditure of Central Government was incurred by four major Ministries/ Departments (Railways, Defence (Civil), Home Affairs and Posts) during 2021-22.
4. Of the total expenditure on Pay and Allowances in 2021-22, the Ministry of Railways continues to have the largest share i.e 36.17%, marginally increasing from 35.82% in 2020-21. Share of Ministry of Home Affairs has remained same at 28.80% and Department of Posts has decreased from 5.50% to 5.46%. Share of Ministry of Defence (Civil) has decreased from 12.34% to 12.15%.
5. The expenditure of UT Administrations is ₹4896.09 crore in 2021-22 as compared to ₹4820.45 crore in 2020-21. Thus, there is an increase in expenditure by ₹75.64 crore over previous year which in relative terms works out to around 1.57%.
6. The expenditure of Indian Missions/ Embassies abroad is ₹1623.56 crore in 2021-22 as compared to ₹1524.92 crore in 2020-21. Thus, there is an increase in expenditure by ₹98.64 crore over previous year which in relative terms works out to around 6.47%.

7. Out of the total expenditure of ₹256112.31 crore on Pay and Allowances of Central Government Civilian Employees including employees of UTs and Missions Abroad, the percentage expenditure on Pay, Dearness Allowance (DA), House Rent Allowance (HRA) and other allowances are 63.59%, 16.71%, 5.95% and 13.75% respectively.

8. Out of the total expenditure of ₹ 15237.17 crore on HRA in 2021-22, the HRA expenditure for 'X' class cities is ₹ 5996.44 crore which is around 39.35% of the total expenditure on HRA.

9. The total number of regular Central Government Civilian Employees in position (including UTs) as on 01.03.2022, is 30.64 lakh as against the sanctioned strength of 40.47 lakh and approximately 24.29 % of the posts were vacant.

10. Almost 92% of the total manpower is covered by five major Ministries/Departments viz, Railways, Defence (Civil) , Home Affairs, Posts and Revenue. Of the total strength of 30.13 lakh (excluding UTs), the percentage share of the Railways is 39.78%, Home Affairs 32.17%, Defence (Civil) 11.45%, Posts 5.44%, Revenue 3.46% and all other Ministries/ Departments 7.70% .

11. Against the sanctioned strength of 10.15 lakh in Central Police Forces, 9.20 lakh employees were in position as on 01.03.2022. In Union Territories (UTs) 0.51 lakhs employees were in position as against a sanctioned strength of 0.69 lakhs as on 01.03.2022.





TOTAL EXPENDITURE ON PAY AND ALLOWANCES OF CENTRAL GOVERNMENT CIVILIAN EMPLOYEES





Share of Major Components in Total Expenditure (in %)





2021-22**










**EXPENDITURE ON PAY AND ALLOWANCES OF THE CIVILIAN EMPLOYEES OF M/O

M/O Defence (Civil) during the Year 2021-22**







EXPENDITURE ON PAY AND ALLOWANCES OF THE EMPLOYEES OF DEPARTMENT OF POSTS (₹ in crore)



Percentage of Expenditure on Pay and Allowances of the Employees of Union Territory Administrations during the Year 2021-22














