PREFACE

The Pay Research Unit of the Department of Expenditure, Ministry of Finance brings out a "**Brochure on Pay and Allowances of Central Government Civilian Employees**" on an annual basis. As in the past, the **Brochure for 2010-11** provides statistical information on expenditure incurred by different Ministries/Departments of the Central Government on Pay and Allowances including Dearness Allowance, House Rent Allowance, Transport Allowance, Overtime Allowance, etc. in respect of its regular employees. The Brochure also contains information on the group-wise number of sanctioned posts and of incumbents in position in various Ministries/ Departments.

2. The data in the Brochure has been compiled on the basis of quarterly returns on expenditure on pay and allowances and annual returns on the strength of Central Government Civilian Employees furnished by the Central Government establishments to the Pay Research Unit of this Department.
3. The Brochure may be of use for personnel planning and for preparation of reliable estimates of financial implications of various proposals concerning pay and allowances of Central Government employees. While all efforts have been made to present the data in a meaningful manner, suggestions for further improvement would be welcome.
4. Ministry of Finance would like to thank all the Central Government Ministries/ Departments/ Organisations for their cooperation in furnishing the data, without which this compilation would not have been possible. This Ministry would also like to acknowledge the contribution of the National Informatics Centre (North Block).

SALIENT FEATURES

1. The total expenditure on Pay and Allowances (excluding Productivity Linked Bonus/ Ad-hoc Bonus, Honorarium, Encashment of Earned Leave and Travelling Allowance) for Regular Central Government Civilian employees including employees of the Union Territories was ` 88,650.74 crore in 2010-11 as compared to ` 89,860.26 crore in 2009-10. Thus, there is a decrease in expenditure by ` 1209.52 crore over previous year which in relative terms works out to 1.35%. The expenditure on pay in 2009-10 included 60% of the 6th CPC arrears (2nd and final installment).
2. Out of the total expenditure of ` 88,650.74 crore, the percentage expenditure on Pay is 56.24%, on Dearness Allowance is 23.00%, on House Rent Allowance (HRA) is 6.31% and on other allowances 14.45%.
3. The expenditure on pay in 2010-11 has decreased by 18.15% as compared to the corresponding expenditure of the previous year as the expenditure on pay in 2009-10 included 60% of the 6th CPC arrears. But, the expenditure on DA, HRA, Transport Allowance, Children Education Allowance and other allowances in 2010-11 has increased by 66.06%, 5.78%, 21.27%, 63.51% and 4.71% respectively as compared to the corresponding expenditure of the previous year.
4. The total expenditure on Pay and Allowances as a percentage of Revenue Receipts and Revenue Expenditure of the Central Government during the financial year 2010-11 was 9.50% and 7.47% respectively as compared to 12.75% and 8.50% respectively during the financial year 2009-10.
5. Almost 84% of the total expenditure is incurred by five major Ministries/ Departments (Railways, Defence (Civil), Home Affairs, Post and Revenue) during 2010-11.
6. Of the total expenditure on Pay and Allowances in 2010-11, the Ministry of Railways continues to have the largest share (more than one third of the total expenditure) at 37.88 per cent, marginally decreased from 38.52 percent in 2009-10. Similarly, the shares of Ministry of Defence (Civil) and Department of Posts have come down marginally from the previous year i.e. 13.75% to 13.68% and 7.84% to 7.69% respectively. The share of Ministry of Home Affairs has increased from 18.71% to 20.09%. Share of other departments has decreased from 21.18% to 20.66%.
7. The expenditure of UT administrations was ` 1957.56 crore in 2010-11 as compared to ` 1787.65 crore in 2009-10. Thus, there is an increase in expenditure by ` 169.91 crore over previous year which in relative terms works out to 9.50%.

8. The expenditure of Indian Missions/ Embassies abroad was ` 729.68 crore in 2010-11 as compared to ` 734.35 crore in 2009-10. Thus, there is a decrease in expenditure by ` 4.67 crore over previous year which in relative terms works out to 0.64%.

9. Out of the total expenditure of ` 5592.43 crore on HRA in 2010-11, the HRA expenditure for X class cities is ` 2611.65 crore which is 46.70% of the total expenditure on HRA.

10. Consumer Price Index Number (CPI) for Industrial Worker (Base 2001=100) has registered an increase of 69.68% over 115.76 points, up to April 2012.

11. The total number of Regular Central Government Civilian Employees in position was 30.82 lakh as against the sanctioned strength of 36.63 lakh as on 1.3.2011.

12. Of the total number of 36.63 lakh sanctioned posts, approximately 15.88% of the posts were vacant as on 1.3.2011.

13. The sanctioned strength of Central Police Forces was 8.57 lakh against 7.64 lakh in position as on 1.3.2011.


14. Almost 91% of the total manpower is covered by five major Ministries/ Departments (Railways, Defence (Civil), Home Affairs, Post and Revenue) during 2010-11. Of the total strength of 30.82 lakh, the percentage share of the Railways is 43.10%, Home Affairs is 25.99%, Defence (Civil) is 12.18%, Posts is 6.78%, Revenue is 3.28% and all other Ministries/ Departments is 8.67%.




Share of Major Departments in Total Expenditure









Pie chart showing percentage expenditure incurred on different components of pay and allowances including employees of Union Territories during 2010-11










