say that Government have decided as follows:-

- Except in the most exceptional circumstances, no new (a) posts should be created for the next nine months i.e., upto 30th September, 1984.
- All existing vacancies, i.e., non-operational posts, where recruitment action has not been taken, should (b) not be filled up for the same period. However, Ministries etc, will have flexibility to readjust their existing staff in a manner as to avoid dislocation of work due to vacancies remaining unfilled.
- The Ministry of Home Affairs etc. are requested to issue suitable instructions to all Departments, attached and subordinate offices under them, to ensure that these instructions are strictly observed. The Ministry of Home Affairs may also issue similar directions for observance of these instructions by Union Territory Administrations.
