

Monthly Summary Report of May,2022

I Financial Position of States

The month of May, 2022 saw downward trend in the States' monthly fiscal assets as compared to April, 2022. The daily fiscal assets of the States at the end of the month of April, 2022 was Rs. 2,64,010.24 crore, whereas at the end of the month of May, 2022 the daily fiscal assets of the States was Rs. 2,37,422.46 crore.

During the month of May, 2022, a total of Rs. 3,568.78 crore was released as Additional Central Assistance for Externally Aided Projects (EAPs) to States as per the details given in the table below:

Consent of Open Market Borrowing (OMB) and Negotiated Loan (NL) allowed to the States:

Department of Expenditure, Ministry of Finance follows the fiscal limits inter-alia mandated by approved recommendations of Finance Commissions through the powers to approve borrowings by States under Article 293(3) of the Constitution of India.

During the month of May, 2022, Government of India (GoI) consent for an amount of Rs. 2,92,980.00 crore was issued to the eligible States under Article 293(3) of the Constitution of India for raising Open Market Borrowing (OMB) during the first nine months of financial year 2022-23. Further, GOI consent for an amount of Rs. 32,873.00 crore was issued under Article 293(3) of the Constitution of India for raising Negotiated Loans.

During the month of May, 2022, as per the recommendations of the 15th Finance Commission, a total of Rs. 9,353.16 crore was released to the States as per the details given in the following Table.

In addition, a sum of Rs. 47,591.62 crore was released to States by Department of Economic Affairs as share of Central Taxes and Duties to States during the month of May, 2022.

Adverse Financial Position of the Centre:

Recent decisions on continuation of PMGKAY, huge increase in fertiliser subsidy burden (both urea & non-urea), re-introduction of subsidy on cooking gas, reduction of excise duty on petrol & diesel and customs duty on various products have created a serious fiscal situation. The budgeted fiscal deficit at 6.40 % of GDP was itself extremely high by historical standards, and deterioration therein poses a risk of serious adverse consequences. It is vital that major subsidy increase/tax reductions are not done. In particular, it is not advisable to continue the PMGKAY beyond its present extension, both on grounds of food security and on fiscal grounds. As it is each family is getting 50 kg of grains, 25 kg at a nominal price of Rs.2/Rs.3, and 25 kg free. This is far beyond the need at a non-pandemic time.
