

Monthly Summary Report of November,2021

I) Financial Position of States

- a) The month of November, 2021 saw an upward trend in the States' monthly fiscal assets as compared to October, 2021. The daily fiscal assets of the States at the end of the month of October, 2021 was Rs. 2,59,783.87 crore, whereas at the end of the month of November, 2021 the daily fiscal assets of the States was Rs. 3,08,255.17 crore.
- b) During the month of November, 2021, a total of Rs. 1,297.86 crore was released as Additional Central Assistance under various Schemes/programmes to States as per the details given in the Table below:

c) Borrowing linked to incremental capital expenditure

Out of the net borrowing ceiling (NBC) of 4% of GSDP for the States for 2021-22, 0.50 percent of GSDP was earmarked for the incremental capital expenditure to be incurred by the States during 2021-22. For this a target for capital expenditure was fixed for each State. The States were required to achieve at least 15% of the target set for 2021-22 in 1st quarter, 45% in 2nd quarter, 70% in 3rd quarter and 100% by end of 31st March, 2022. Second review has been carried out in the month of November, 2021 and on the basis of capital expenditure incurred by States upto the second quarter of the year 2021-22 (April, 2021 to September, 2021) eight States namely, Chhattisgarh, Kerala, Madhya Pradesh, Manipur, Meghalaya, Punjab, Rajasthan and Telangana have been granted permission to borrow an additional amount of Rs.16,781 crore.

- d) During the month of November, 2021, as per the recommendations of the 15th Finance Commission, a total of Rs. 23,317.02 crore was released to the States as per the details given in Table:-

*15th Finance Commission has recommended Grants for Health Sector to be channelized through Local Governments amounting to Rs. 13,192.00 crore for the year 2021-22. To Strengthen and plug the critical gaps in the health care system at the primary health care level, the 15th Finance Commission has also identified interventions that will directly lead to strengthening the primary health infrastructure and facilities in both rural and urban areas. Based on the recommendations from Ministry of Health & Family Welfare, the Department of Expenditure, has released the Health Sector Grant of Rs. 12,251.82 crore to the 28 States during the month of November, 2021.

- e) In addition, a sum of Rs. 95,082.00 crore was released by Department of Economic Affairs as share of Central taxes and duties to State during the month of November, 2021.
- f) **Special Assistance to States for Capital Expenditure for 2021-22:** Capital Expenditure amounting to Rs. 6,585.00 crore has been approved for the States of Bihar, Chhattisgarh, Himachal Pradesh, Madhya Pradesh, Maharashtra, Punjab, Sikkim, Telangana, Gujarat, Rajasthan, Uttar Pradesh, West Bengal, Odisha, Nagaland, Haryana and Goa under the scheme of 'Special Assistance to States for Capital Expenditure: 2021-22' and an amount of Rs. 3,276.960 crore has been released to the States up to the month of November, 2021.
- g) During the month, meetings with all Departments for fixation of Revised Estimates for 2021-22 and Budget Estimates 2022-23 were concluded.
