I <u>Financial Position of States</u>

The month of September, 2022 saw downward trend in the States' monthly fiscal assets as compared to August, 2022. The daily fiscal assets of the States at the end of the month of August, 2022 was Rs. 2,64,731 crore, whereas at the end of the month of September, 2022 the daily fiscal assets of the States was Rs. 2,29,267.92 crore.

During the month of September, 2022, a total of Rs. 2529.1318 crore was released as Additional Central Assistance for Externally Aided Projects (EAPs) to States as per the details given in the Table below:

Consent of Open Market Borrowing (OMB) and Negotiated Loans (NL) allowed to the States:

During the month of September, 2022, Gol consent of Rs. 146 crore was issued to States under Article 293(3) of the Constitution of India for raising Open Market Borrowing (OMB) for first nine months of FY 2022-23 and for availing Negotiated Loan (NL) of Rs. 1,128 crore from Central Financial Institutions (CFIs) under Article 293 (3) of Constitution of India during current financial year 2022-23.

During the month of September, 2022, as per the recommendations of the 15th Finance Commission, a total of Rs. 9822.62 crore was released to the States as per the details given in the following Table:-
