Subject: - Reduction in Public Holidays for industrial employees-Pay Commission's recommendations regarding:

The following recommendation of IIIrd Pay Commission relating to Hodidays' have been accepted by Government vide serial No. 37 of the Annexure to Resolution No. 70(34)/73-Imp. Cell dated 1.11.1973 of the Ministry of Finance:-

- (a) No section of employees should be allowed more than 16 Hodidays in a year.
- (b) The practice of declaring one of the restricted holidays as a public holiday whenever any of the approved 16 closed holidays falls on a Sunday or a Second Saturday, should be discarded as soon as possible.
- (c) No change need be made in the system of restricted holidays except that an attempt should be made to control the number of festivals declared as restricted holidays.
- (d) No change in regard to the number of public holidays need be made in respect of those employees who are entitled only to 3 National holidays or 9 effective holidays.
- According to the existing instructions contained in the Ministry's 0.M.No. F.8(7)-Est.(Spl)/60 dated 7.1.1961, Industrial Employees are entitled to 3 National Holidays and 13 effective public holidays. For future, in line with the accepted recommendation of IIIrd Pay Commission, establishments employing Industrial employee should also decide, once for all, the remaining 13 occasions for which holidays should be declared. The occasions declared as closed holidays should not be changed in future irrespective of any of 16(inclusive of the 3 National holidays) holidays falling on a Sunday or a Second Saturday. Similarly the list of Restricted hollidays should also be drawn up by such astablishments, once for all. But the list when drawn up should not be more in number than the number of Restricted Holidays prescribed for the year 1974 for them.
