SUBJECT:- Revision of scales of pay of Grade I of the C.S.S. and the posts of Under Secretary to the Government of India.

Sir,

I am directed to refer to para 3 Ministry of Home Affairs letter No.F.14/10/61-CS(A) dated the 5th April, 1962 on the subject mentioned above, and to say that all officers of the Central Secretariat Service and other officers who were drawing pay in the scale of Rs.900-50-1200 on 1st April, 1962 in a substantive or officiating capacity in Grade I of the Central Secretariat Service or in the post of Under Secretary to the Government of India shall effect from this date in accordance with Audit Instruction 1 below F.R.22.

Such of those who were drawing on 1st April, 1962 the maximum of the scale of Rs.900-50-1200 for a period of one year or more (including any periods of leave counting for increment) shall have their pay fixed at Rs.1250 in the revised scale with effect from 1st April, 1962 in accordance with this Audit Instruction, and those who have drawn pay at the maximum of the scale of pay of periods of leave counting for increment) on 1st April, 1962 shall have their pay fixed at Rs.1250 in the revised scale as and when Rs.1200 in the scale of Rs.900-50-1200.

- 2. The provisions contained in the Audit Instruction referred to above shall also hold good in the case of those officers who had officiated for short spell in Grade I of the Central Secretariat Service during the period from 1st July, 1959 to 31st March, 1962 and drew pay in the scale of Rs.900-50-1200 and are reappointed to Grade I after 1st April, 1962.
- 3. However, in the case of officers who had officiated in Grade I of the Central Secretariat Service prior to 1st July, 1959 and did not officiate for any period between 1st July, 1959 and 31st March, 1962, the pay in the revised scale on reappointment after 1st April, 1962 shall be fixed at a stage which shall be equal to the stage they would have drawn in the scale of Rs.900-50-1200 in accordance with Rule 13(2) of the Central Ciril Service(R.P.) Rules 1960. Their next increment also will be regulated under
