Subject: - Implementation of the recommendation of the Third Pay Commission - Draughtsman.

The undersigned is directed to refer to para 81(iii) of Chapter 14 of Third Pay Commission's report wherein the Commission has recommended, inter-alia that half the number of posts of Draughtsmen in the scale of Rs. 205-280 should be placed in the scale of Rs. 425-700 and the remaining half should be placed in the scale of Rs. 330-560 with effect from 1.1.73. A point has been raised as to how the pay of the Draughtsmen in the pre-revised scale of Rs. 205-280 who were fixed in the revised scale of Rs. 330-560 with effect from 1.1.73 in accordance with the above recommendation of the Pay Commission, will be fixed on their appointment to the scale of Rs. 425-700 after 1.1.73,

The matter has been examined. The President is pleased to decide that such of the Draughtsmen in the scale of R. 205-280 who have been placed in the lower scale of R. 330-560 with effect from 1.1.73 should be allowed the benefit of fixation of pay under FR 22-C on their appointment to the scale of R. 425-700 subsequent to 1.1.73.

3. While fixing the pay of the Draughtsmen in the manneer indicated in para 2 above, it may happen that the senior Draughtsmen in the pre-revised scale of &. 205-280 who were placed directly in the higher scale of &. 425-700 with effect from 1.1.73 may be drawing pay less than those juniors to them who were initially placed in the lower scale of &. 330-560 and were subsequently promoted to the higher scale of &. 425-700. In such cases, the President is pleased to decide that the pay of the senior Draughtsmen may be stepped up to the level of the pay of his junior in terms of orders contained in this Ministry's 6.M. No.Fol(35)-E.III(A)/74 dated 18.7.74. The payment of arrears will be subject to the provisions of the 0.M. dated 18.7.74.
